Presentation from the Consultant:

Planning Process:

Sperling Hansen reviewed where the committee is in the Solid Waste Management Plan Update planning process:

- ➤ Near the end of Phase 2 in the Financial Implications
- > Sperling Hansen will be putting all the information together
- Phase 3 Community and Stakeholder Consultation

- ➢ BC's Guiding Principles

Questions from the above Topics:

Are the key drivers that are listed in this document the ones that the Government requires as part of an updated SWMP and is the Government going to make the principles mandatory.

Answer: The Government has provided a guideline for updating SWMP. When a Regional District is updating their SWMP they focus on certain areas of the key drivers more than others that provide the outcome that works for their area. The guidelines is a goal for achieving things on a basis that they can compare with other regions on a per region basis and the size of the area involved. Services can be expensive to be provided and will not always make sense to be provided. Ie: comparing a large region like Vancouver to a rural area like the RDEK. As long as the spirit of what the government requires is being met.

Do you have a sense of what has made the biggest impact of the volume of waste/person.

Answer: It was decided to track only the wastes going to landfill rather than the diverted wastes as there were too many variables. The areas that have composting have the lower rates of waste/capita. The communities that are the highest waste producers are those that do not have organics diversion.

General Observations:

- The advisory committee discussed at length the opportunities regarding recycling options, and scenarios that affect the costs associated with the service.
- The advisory committee also discussed the new Recycle BC Depot at the Kimberley Transfer Station and the need to provide businesses with a way to continue recycling as Recycle BC is not for the business sector.
- Discussion also took place around reducing single use plastics with suggestions being given to do this through advocacy to work with provincial government.
- Discussion took place around composting and the financial support being offered for centralized composting. The Elk Valley is not in support of backyard composting due to possible conflicts with bears.
- The advisory committee talked about limiting the hours at the unmanned rural sites and the possible closure of some.
- Potential changes to increase or decrease services is something that would have to be further discussed and decided through the municipality and the Regional District of East Kootenay Board.

Questions for further analysis:

- Will taxation be increased as well as the addition of more tipping fees, it was felt that
 there is a need to have more consultation with the public before moving forward with
 changes.
- Do we have a strategy now for illegal dumping, there is a program in the Elk Valley for back country clean up and no tipping fee for clean up on public lands.
- When putting forward communication around the savings that a person could have by not producing more garbage if additional user fees are introduced, but a reduction in taxation could be a way to have a positive outcome.

Next Steps:

After June 5 mtg, there will be a consultation process with the public, we will then meet again with the review committee, the plan will then go to the Board for consideration and then be submitted to the ministry.

Final meeting with the committee may be in September or October depending on the public input portion.
